169/24	PA24/04637 Outline planning permission with all matters reserved for construction of two self-build affordable dwellings and associated works, Land Adj To Penlu Four Cross Treluswell Object as the proposal does not comprise as a settlement boundary in the Cornwall Local Plan. Members noted the proposal is adjacent to a row of houses at Four Cross, and it would share relatively good access with those houses. Using advice provided by Cornwall Council the NDP Group for Ponsanooth have undertaken a piece of work which draws up settlement boundaries for the emerging NDP as currently none exist in our Parish. The work shows that this row of houses would not comprise a settlement that meets this advice, and for information the nearest settlement boundary would be those houses to the south at the petrol filling station. We understand that not being next to a settlement indicates that the proposal should not benefit as an 'exception site' under Policy 9 of the Cornwall Local Plan which concerns affordable housing led schemes where they are next to settlements. Members also aware of the previous planning history and an appeal decision, where the Inspector concluded that this row of houses was not a settlement and dismissed a previous housing scheme there. Putting this into a wider context the NDP Group have gathered work which shows that there is a strong level of need for affordable housing in our Parish, but there has been a very low level of new affordable housing delivery in our Parish over the last decade or so. It should also be said that looking at aerial photos of the site it appears that it has been used in the past and probably has a closer relationship with the existing row of houses than the more open countryside next to it. If however planning permission were to be recommended it is suggested that the occupation of the houses be tied via a legal agreement so that they remain as affordable and help provide affordable housing in our Parish and not sold onto the open market. It would also be desirable to safeg
