- •Film, photograph or make an audio recording of a meeting.
- •use any other means for enabling persons not present to see or hear proceedings at a meeting of a parish council as it takes place or later.
- •Report or comment on the proceedings in writing during or after a meeting or orally report or comment after the meeting.
